FOURTH: I hereby nominate and appoint my son-in-law, THOMAS J. TIERNEY, Executor of this my Last Will and Testament and I give him as such Executor, full power and authority at any time to sell, mortgage, pledge, exchange, or otherwise deal with or dispose of, the property comprising my Estate upon such terms as he shall deem best, to settle and compound any and all claims in favor of or against my Estate as he shall deem best, and for any of the foregoing purposes, to make, execute and deliver any and all deeds, contracts, mortgages, bills of sale or other
