

LAST WILL AND TESTAMENT

OF

CHARLES J. TROST

I, CHARLES J. TROST, of the City of Chicago, County of Cook and State of Illinois, being of sound and disposing mind and memory do hereby make, ordain, publish and declare this to be my Last Will and Testament, hereby revoking any and all former Wills and Codicils by me at any time heretofore made.

FIRST: I direct that all my just debts and funeral expenses be paid as soon after my death as practicable.

SECOND: All the rest, residue and remainder of my Estate real, personal or mixed, of whatever character, or wheresoever situated, of which I may die seized or possessed, or over which I may have testamentary control, or to which I may be in any way entitled at the time of my death, (including any and all lapsed legacy or legacies hereunder), I give, devise and bequeath as follows:

- a. Two-sixths (2/6) to my daughter, JEANETTE L. TIERNEY
- b. One-sixth (1/6) to my son, NORMAN C. TROST.
- c. One-sixth (1/6) to my son, CHARLES J. TROST, JR.
- d. One-sixth (1/6) to my son, PAUL TROST.
- e. One-sixth (1/6) to my son. FRANCIS A. TROST.

THIRD: I have in mind my son LAWRENCE J. TROST, but for reasons which I deem sufficient, I make no provision for him in this, my Last Will and Testament.

FOURTH: I hereby nominate and appoint my son-in-law, THOMAS J. TIERNEY, Executor of this my Last Will and Testament and I give him as such Executor, full power and authority at any time to sell, mortgage, pledge, exchange, or otherwise deal with or dispose of, the property comprising my Estate upon such terms as he shall deem best, to settle and compound any and all claims in favor of or against my Estate as he shall deem best, and for any of the foregoing purposes, to make, execute and deliver any and all deeds, contracts, mortgages, bills of sale or other

instruments necessary or desirable therefor. And I hereby direct that no surety or sureties be required upon his official bond as Executor hereof.
